## **Life Coaching Agreement**

#### 1. Services

The Coach is not a medical professional, therapist, or counsellor. The coaching provided is for general personal support, mindset, and wellbeing purposes only, and does not replace medical, psychological, or therapeutic care. Clients should seek advice from a qualified healthcare provider for any medical or mental health concerns.

# 3. Confidentiality

All information shared during coaching sessions is treated as confidential and will not be disclosed to third parties without the Client's consent, except where disclosure is required by law or where there is a risk of harm to the Client or others.

## 4. Payment Terms

All coaching sessions and packages must be paid for in advance through the With Nix website. Session times will be confirmed upon receipt of payment.

# 5. Cancellations and Rescheduling

Clients may reschedule or cancel a session with at least 24 hours' notice. Cancellations made with less than 24 hours' notice may result in forfeiture of that session. Refunds are not typically offered once a coaching package has commenced.
